I agree that if I get injured by a dog at Camp Ruff House, LLC, I will not hold Camp Ruff House liable for any injuries or damages that may occur.

****This section applies to anyone who brings their dog on the Camp Ruff House premises for any reason:**

I have disclosed to Camp Ruff House, LLC all known risks, dangers, and medical conditions associated with my dog(s). I understand that I am solely liable for medical expenses and damages that result from injuries caused by my dog, or that I will resolve the matter directly with the owner of the other dog.

I understand that Camp Ruff House, LLC may refuse service to my dog for any reason it deems necessary, including but not limited to, overly aggressive behavior, overly excessive barking, and illness.

I agree that there are inherent risks in sending my dog to any dog activity center, such as illness or injury, and I accept these risks because they are outweighed by the benefits. Camp Ruff House, LLC will not be liable for any illness or injury that may occur to my dog.

I understand that I am financially responsible for the charges that my pet will incur during his/her stay at Camp Ruff House, LLC. I also understand that I am responsible for any damages that my dog might inflict to bedding, drywall, kennels, etc during his/her stay.

All charges will be settled at the time I pick up my dog from their stay at Camp Ruff House. I authorize Camp Ruff House to take actions they deem necessary to ensure the health, well being and safety of my dog, and to take reasonable action to resolve any medical problems that may arise. I agree to assume full financial responsibility for any and all expenses incurred as a result of their actions. I understand that Camp Ruff House staff is expected to make a reasonable attempt to contact me before incurring such expenses. If they are unable to reach me, and an emergency situation should arise, I give my permission to take appropriate action.

I waive all claims or actions against Camp Ruff House, LLC relating to the care, control, health and/or safety of my dog arising while my dog is in their care.
